# Contractor Registration Application

## Definitions: Superior Code of Ord. Sec.34-56

“Contractor” means any person or company engaged in any type of construction or remodeling work for consideration, including but not limited to, construction or remodeling of accessory buildings, and/or appurtenances thereto, or any sidewalks, driveways, or other approaches to such a building, roofing, walls, siding, windows, doors, chimneys, water softeners, humidifiers, purifiers, concrete work, landscaping, excavating, painting and similar services.

## Summary Notes:

1. Building contractors who work on 1 or 2 family dwellings (residential) must provide their State of Wisconsin Dwelling Contractor Certification and Dwelling Contractor Qualifier numbers upon this application. These numbers are also required on all permit applications.
2. All electrical contractors wishing to perform electrical work in the City of Superior are required to hold the WI Master Electrician’s License and the WI Electrical Contractors License.
3. As of January 1, 2015, all HVAC contractors wishing to perform gas piping in the City of Superior will be required to hold the WI HVAC Qualifier.

## Bond and Insurance Requirements:

1. \$25,000 Surety Bond Certificate\* (expiration date December 31, 2020 or continuous until canceled)
2. Certificate of Insurance\* (\$1,000,000 aggregate per occurrence)
3. Proof of Workman’s Comp. or signed waiver

\* Building contractors holding the Dwelling Contractor Certification or Dwelling Contractor Restricted must provide insurance or bond in accordance with SPS 305.02. (\$25,000 Surety Bond OR Certificate of Insurance \$250,000 aggregate per occurrence.)

## Construction Activities List:

Contractors performing the following construction activities listed herein are required to obtain a City Contractor Registration. Other activities not listed herein, may also require a City Contractor’s Registration. Please check with City’s Building Safety Inspection Office for verification or questions.

## Exceptions for Certain Contractors:

1. City contractor registration may not be required for contractors working exclusively on any of the following: City or state roads, highways, sidewalks or related projects; city water, sewer, gas, electric and communication infrastructure projects; construction and/or installation of components of state owned buildings; construction, maintenance or repair of railroad owned transportation equipment, tracks, and/or related to the supporting of equipment and tracks; construction, repair and maintenance of commercial ships and related services.d)
2. Construction or work performed on state owned university buildings, property and/or equipment.
