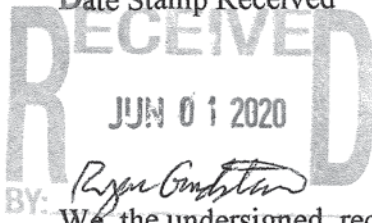

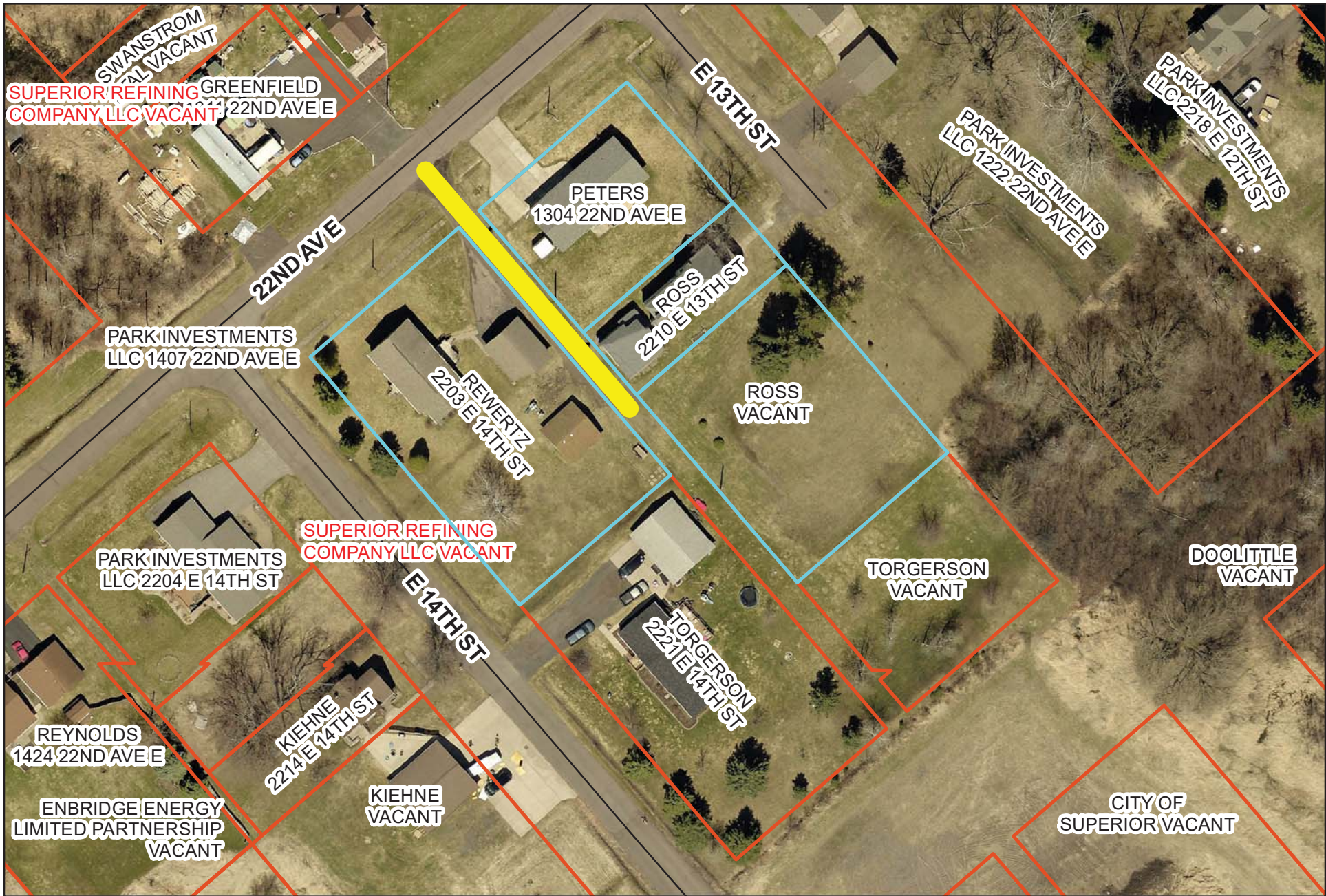

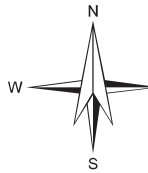


## Alley Improvement Project 2021
