Resolution #R19-13440

Resolution introduced by Councilor Sutherland calling for censure of Councilor Van Sickle for recent social media comments relating to the City Attorney.

Whereas on September 2, 2003, the City Council adopted Resolution R03-12467, outlining the nine tools of civility. It is essential that all elected leaders of the city set the example and tone for demonstrating respect and civility; and

Whereas the City Code of Ordinances, Section 2, Article III, Code of Ethics Sec. 2-343 (b) in part reads: “Furthermore, they are to observe in their official acts the highest standards of morality and to discharge faithfully the duties of their office regardless of personal considerations, recognizing that the public interest must be their prime concern. Their conduct in both their official and private affairs should be above reproach as to foster respect for all government.”

And whereas on June 14, 2019 Councilor Van Sickle posted comments on Facebook and Twitter which violated the values of the city council and which demonstrated a lack of judgment and professionalism, and possibly slanderous, by stating in part:

“Prell has a long established reputation of repugnant incompetence. No one of merit would take this seriously. The opinion itself is riddled with manipulated and irrelevant citations and plenty of contradictions and worse, pure laziness.”

The City Council of the City of Superior hereby reaffirms its commitment to insuring all citizens and employees are treated with respect through civil public dialogue. The City Council further calls on Councilor Van Sickle to reaffirm her commitment to lead civil public dialogue through positive example.
